
INSTALLATION FOR WALL MOUNTING

- 1) Attach the mounting bracket to box or wall.
- 2) Attach the power supply to this mounting bracket.

MOUNTING INSIDE THE LAW-1 AMPLIFIER CABINET

- 1) Remove four screws on the sides of LAW-1 and lift the cover from the base.
- 2) Attach the mounting bracket to the LAW-1 chassis, using 4 x 6mm screws supplied with the power supply.
- 3) Attach the power supply to this mounting bracket.
- 4) Connect the red and black wires within the LAW-1 to plus and minus terminals respectively of the power supply.
- 5) Replace the amplifier cover (note 1).
